CONSIGNOR AGREEMENT

FURNITURE: Acceptance of furniture must be pre-approved by our staff prior to arrival for sale. It is the consignors responsibility to eliminate “No-Thank-You” (NTY) items before attempting to consign them. At consignors intake appointment, staff will screen items, discuss pricing expectations and explain policies.

- I choose not to wait for intake screening, and authorize WSS to choose & price saleable items.
- I agree to donate any NTY items WSS chooses not to accept.
- I will retrieve any NTY items within 3 days. *(If not retrieved, WSS will dispose or donate.)*

CONSIGNMENT PERIOD: Consignor agrees to allow Wabi Sabi Shop to market items for 90 days. Note contract start and end date above. Items picked up before the 90-day contract will be subject to a handling charge of \$25 or 25% of selling price, which ever is greater. Items left after 90 days will be reduced 50% until expired items have been retrieved or as directed below:

EXPIRED ITEMS: If your items have not sold at the end of the 90-day period, you have three options:

- Re-consign items at a lower price for an additional 30 days. If not sold, then:
- Allow us to donate unsold items to charity and receive a tax deductible receipt.
- Retrieve unsold items within 7 days of contract expiration: this is your **FINAL PICK-UP DATE**

FINAL PICK-UP DATE is printed at the top of this agreement. Items left past this date becomes the property of WSS.

PRICING: We will work with you to arrive at a favorable sales price. Once a price is established, we will not sell it for less. Markdowns will follow a 15% reduction every 30 days. *(Additional reductions may apply during holiday specials or quarterly sales in Nov, Feb, May, and Aug.)* If we think the price should be adjusted during the final markdown, you will be consulted. Seasonal merchandise will be reduced 50% two weeks before the holiday. Unsold seasonal items become the property of WSS one week after the holiday and will then be donated to charity.

CONSIGNOR PAYMENTS & FEES: A one-time \$10 account set-up fee will be deducted from your first check. You will receive 50% of our agreed selling price. Consignors checks will be ready for pick-up at the shop by the 10th of each month for accounts amounting to \$20 or more, generated by the previous month’s sales. For consignors who live out of town, checks are mailed on the 10th of each month and will have \$2 deducted to cover postage and handling. Or if you prefer:

- Please mail my checks. *(The same \$2 fee will be deducted.)*

As the consignors, I acknowledge that all items presented are mine to sell and are free of all liens and encumbrances. I agree to the above terms and conditions. This Consignment Agreement constitutes the total agreement between both parties and will be governed and construed pursuant to the laws of the state of Minnesota.
